In preparation for the 2016 Maryland legislative session there are three women-centered events scheduled:

 The MLAW Fall Conference will be held on Saturday, November 14, 9:30 a.m.-1:00 p.m. in Gaithersburg. Bills being proposed this year will be presented to the group for consideration of sponsorship by MLAW (Maryland Legislative Agenda for Women). Later in the fall the MLAW members vote on which bills will be supported. - 2) Late January 2016 Maryland Women's working to draft legislation to address various women's issues in Maryland. The participants get to share ideas with those crafting the bills. This is very interesting and attended by many of our legislators.
- 3) Early February MLAW Legislative reception in Annapolis. Meet with the legislators to discuss the bills being supported by MLAW this year.

2016 Maryland Legislative Agenda for Women Maryland Legislative Agenda for Women, the coalition of Maryland women's advocacy organizations, is celebrating its twentieth year during this legislative year. MLAW met in Gaithersburg on November 14 for members to learn about bills being proposed this year for MLAW's support. In order to present, a bill must

address a women's issue, have an identifiable Legislative Briefing hosts sessions led by teams supporting organization shepherding it through the legislative process, have a sponsor in the legislature and have a reasonable chance of success. Of seven bills supported by MLAW during the last legislative session, four became law. Maryland is unique among states in having such a coalition.

> Both the Maryland House and Senate have a record number of newly-elected members this year. Most of the new senators are veteran politicians already, having experience as House members or elsewhere. Most of the new members of the House of Delegates are new to politics. The meeting began with Q & A with a panel of four new delegates, two serving on the Judicial Committee (Marice Morales and Will Smith. Montgomery County) and two on the Health and Government Operations Committee (Erek Barron, Prince George's, and Karen Young, Frederick). Twelve or more legislators attended, men as well as women. This year's bills focus more on economic issues: last year had more bills related to safety. Here are the bills seeking MLAW's support. Equal Pay for Equal Work Act. This legislation provides protection for workers to discuss their wages without fear of retaliation, bars employers from providing less favorable opportunities based on sex or gender identity and updates Maryland's Equal Pay for Same Work law by including gender identity as a protected category.

Fair Scheduling Act of 2016. This bill will provide hourly workers with some measure of predictability in their schedules so that they can plan for and balance non-work responsibilities by incentivizing employers to build stable, family-friendly schedules.

Maryland Healthy Working Families Act. This would enable workers, particularly low-wage workers, to earn a limited number of annual paid sick and safe days from their employers. (The safe time is provided for victims of domestic abuse or sexual assault to seek health care or legal protection.)

Earned Income Tax Credit Expansion. This bill would help young lower income workers who are unable to meet expenses by lowering the age, increasing eligibility, and increasing benefits.

Stalking, Harassment, Misuse of Electronic **Communication or Interactive Computer Service, Revenge Porn.** Currently due definition in Maryland's criminal law, it is difficult to prosecute these cases. This bill contain changes to law recommended by the

Governor's Family Violence Council that will enable prosecution.

Rape Survivor Family Protection Act. This bill terminates the rights of rapists when a child is conceived as a result of rape.

School Food Transparency. School districts will be required to list all foods sold in cafeterias on breakfast and lunch menus, including a la carte or snack foods. Then parents will have the knowledge needed to block sales of a la carte items or demand healthier choices. Sensible Sugar in Schools. School districts will be required to form a committee to formulate policy to reduce added sugar intake in cafeteria meals to the levels recommended by the American Heart Association (no more than 3 teaspoons for children ages 4-8 and no more than 5-8 teaspoons for preteens and teens).

Universal Voter Registration Act. This bill automatically registers all eligible Maryland residents by accessing several state agency databases including MVA, the Marvland Health Benefits Exchange and local social service departments.

Post-Secondary Education Child Support post Age of Majority. This bill mandates child support or full time and violence for victims now provided by Title IX. college or university attendance until the age of 21. Family and Medical Leave Insurance Program. This would establish a paid family and medical leave insurance program similar to unemployment insurance for the 87% of the Marvland workforce who do not earn paid family and medical leave. Precise utilization projections for program design in Maryland have been provided by the Institute for Women's Policy Research as part of a grant from the U.S. Department of Labor. Expansion of Maryland's "Vacating Convictions" Law for Survivors of Human Trafficking. This expands last year's enacted law to include survivors of labor trafficking and includes additional coneligible for vacatur, such as loitering, trespassing, related to the trafficking, to lessen the impact of these convictions and help victims obtain housing, jobs, and get out of poverty.

The next step in this process is for members of MLAW to decide by their votes which bills will be supported. Individual (\$35) and organizational (\$70) membership is available at the MLAW web site. Voting will occur in early December. Prior to the session beginning, Marylanders have the opportunity to be listed among supporters of the entire slate: check the MLAW web site. In late January there will be an MLAW reception in Annapolis prior to the session, attended by the

sponsoring delegates and senators and MLAW members.

#### National issues:

The U.S. Senate is considering the Workplace Advancement Act (S. 2200). The Workplace Advancement Act puts forth only one solution to address the gender pay gap: a very weak, very narrow non-retaliation provision that would require workers to use legally "magic words" when initiating discussions about pay. The bill fails to close the many loopholes used to justify discriminatory wages, while recommitting to the outdated legal principles of the Equal Pay Act of 1963.

The Violence Against Women Reauthorization Act in 2013 is now supported by regulations that went into effect July 1. Schools are making important strides to improve their response to incidents of rape, dating violence, domestic violence, and stalking. AAUW opposes both the Safe Campus Act and the Fair Campus Act, two recently proposed bills. The first is a bill that would not require accommodation to victims until a conviction is reached: the second undermines the protection for an education free from harassment To easily support AAUW national issues, become a Two-Minute Activist.

#### Legal Advocacy Fund—

The Real 10. The U.S. Treasury has announced that the image on the new \$10 bill will be that of a woman.

The big issue here is that there still is a fair pay gap with women earning an average of only \$.79 for every \$1.00 earned by men. The gap for Black and other minority women is even greater. To call attention to this pay gap, AAUW invites its members to go to <u>http://thereal10.org</u> and upload their images to show what the real \$10.00 bill looks like to women. This image can then be posted on social media pages and shared with friends to help fight for equal pay.
