AAUW Legislative Update By Roxann King

Sign up to list yourself as a supporter of the Maryland Legislative Agenda for Women this year by completing this simple online form before February 5. Our Branch is a member of MLAW. MLAW is a coalition of individuals and groups in Maryland that determine each year which bills they will support that promote the well-being of women and families in Maryland. Last, most bills supported by MLAW became law. Details for the

bills below that are being supported this year can be found at the MLAW website.

The Maryland legislative bills being supported this year are:

- *Equal Pay for Equal Work
- *Fair Scheduling Act of 2016
- *Maryland Healthy Working Families Act
- *Stalking, Harassment, Misuse of Electronic Communication or Interactive Computer Service
- *Rape Survivor Family Protection Act
- *Expansion of Maryland Vacating Convictions Law for Survivors of Human Trafficking
- *Family and Medical Leave Act Insurance Program
 Two annual events mark the beginning of the
 legislative lobbying efforts for women in Maryland.
 - Maryland Women's Legislative Briefing will be held on Sunday, January 31, from 12:30 to 6 p.m. at the Universities at Shady Grove. Hundreds of advocates, policy makers and leaders from around the state gather to plan action and discuss issues related to women and girls. Attendance cost \$25.  - MLAW will hold its annual Legislative Briefing and Reception on Tuesday, February 16, from 4:30 to 6:30 p.m. in the Miller Senate Office Bldg. in Annapolis. It is well attended and tickets are free, but you need to register now. Click here to register.

Please let me know if you plan to attend either of these events so that we can plan to carpool or meet there at: (roxann.king1@verizon.net). Both events are well-attended by AAUW members from different branches around the state.

Also, Anita Rosen, our state public policy vice president, wrote this week: "Take a look at current proposed legislation in Maryland for our current session in Annapolis related to education. There are several very good bills to support, including issues around age appropriate education, around sexual assault and abuse legislation (MD H 72) and "around educational loan assistance to orphans and children in foster care."

Currently \$6 of the local dues that you pay to our Branch annually is returned to the national AAUW to support efforts to shape national policy. AAUW does this three ways. It supports research, collects and disseminates data that influences better enforcement of already existing laws (like title IX) and that promotes

new legislation supporting women's issues. AAUW is often called to testify when women's issues are brought before congressional panels because AAUW has the data

AAUW biannually polls members about which issues it will support. Then on Thursdays, when Congress is in session, AAUW's Lobby Corps (which includes several of our active members) visits congressional offices lobbying specific issues each week.

Finally, AAUW provides legal aid to support plaintiffs in lawsuits that focus on critical women's issues, as in its support for the victims of sexual assault in the military with their lawsuits.

Information about current activities is available in AAUW's Action Network newsletter, which sends out information about legislation and action items fairly often while congress or the Supreme Court is in session. Here are a few items from this week:

- AAUW has started a Get Out the Vote (GOTV) campaign for 2016 with a webinar recently.

NOMINATING COMMITTEE CALL FOR NOMINATIONS

The nominating committee for this year is currently Roxann King, Dorothy McGuiness and Kay Monk. Two members have had to resign recently.

Last year, changes were made to our bylaws to stagger co-positions for each of the major offices. (For this first year the President, when elected, will be serving alone until a co-President is elected next year.) Every year from next year forward, we will be electing a co-President, a co-Vice President for Programs and a co-Vice President for Membership for two year terms. Mary-Lynne Neil, current co-VP for Programs will continue to serve her second year with the incoming co-VP for programs. Membership VP. Diana Larmore. elected last year, has recently had to resign, and so that VP when elected will be serving alone until a co-VP is elected next year (note there is a supportive committee in place for membership). A secretary for our branch must be elected, with one year remaining in the current term. Five members need to be elected to the nominating committee, three for terms of two years and two for one-year terms. Descriptions of position responsibilities can be found in branch documents page inside the "Members Only" page at our branch website: annearundelcounty-md.aauw.net. (The password for this website will be sent in the email where this newsletter was attached.) The "Members Only" page also includes our members' directory, minutes from branch and board meetings and our branch documents such as by-laws and board and branch policy documents.

Branch board meetings are monthly from August through June currently on the third Wednesday, with no meeting in December and conference-call meetings when inclement weather prohibits gathering. The monthly board meetings are open to the membership and are also attended by committee chairpersons for the educational awards funds, the book sale, public policy, communication, publicity and the STEM activities. There are other committee heads that attend occasionally as needs arise. If you are interested in joining our board of directors or think that perhaps you might be convinced into doing so, speak with one us or talk with one of the current board members. The three funds are listed below. If you do not specify a fund, then your donation will be distributed 50%, 25%, 25%, respectively, which is how our Branch has determined the distribution of branch award fund monies.

- Women-to-Women awards to local women with needs for pursuing higher education;
- Transfer Scholarship awards to Anne Arundel Community College graduates transferring to a college or university;
- AAUW Educational Opportunity Fund (EOF) awards, presented by the national AAUW organization to women for graduate education or research related to women's issues.

You can also specify your donation towards scholarships to the annual **National Conference for College Women Student Leaders (NCCWSL)**, held annually at University of Maryland in College Park. We annually fund participation by one or more student leaders from our local colleges.

Transfer Scholarship recipients for the current year continue to show excellence in their academic work and college participation. Abigail Anderson, studying elementary education at Notre Dame University in Baltimore, received a perfect 4.0 GPA in her first term there. Teisha Miles, pursuing community leadership at the University of Baltimore, received a 3.7 GPA in her course work while excelling in community activities. She has been honored additionally by being invited to MC the Martin Luther King Awards Breakfast at Anne Arundel Community College this year.

Both young women are fully enrolled for the spring term and have received the second half of their scholarship awards.

The applications for the 2016-17 Transfer Scholarships are ready for distribution. We will again be able to offer two scholarships of \$1500 each. While smaller than many years, these grants will aid potential leaders in their final undergraduate years.

Applicants must be entering their junior year at a four year college or university, have attended Anne Arundel Community College, have a GPA of 3.0 or higher, and show evidence of civic responsibility and leadership potential. Please note: pending or recent high school graduates are not eligible for this scholarship. The deadline for completed applications is April 1. Recipients will be announced at the May brunch.

The committee still is seeking new members as this year will be the final term for all current members. All have served for several years.

OUR AAUW BRANCH BUDGET

Title: Do You Know Where Your Money Comes From and Goes To?

This is the first in a series of brief articles meant to support members' understanding of our Branch's income and expenditures, in anticipation of budget votes. Numbers reflect approximation at the time of this newsletter. Treasurer Dianne Dezio efficiently and accurately manages the Budget. A detailed copy of the Branch budget is reviewed monthly at Board meetings and is audited yearly. The robust activities of the Anne Arundel Branch of AAUW act to solicit funds and then apply them to a variety of mission-oriented purposes. Where does our Branch funding come from? Where does it go? Did you know?

- ✓ When an individual joins or renews, of the \$70 paid by a regular member, \$49 goes to the National Office, \$10 to the Maryland State AAUW, and \$11 to the Anne Arundel Branch. While membership numbers evolve during the fiscal year, at the publication date of this newsletter, our Branch has 73 regular members (and 7 Life members). This accounts for \$803 of our Branch's operating budget.
- ✓ Individual donors (thank you!!) also support the Branch—this year, financially, to the amount of \$256. There is no way to calculate the monetary value of in-kind time and energy offered by officers, committee chairs and members, and members-at large (and spouses and friends) who do anything and everything to support Branch activities.
- ✓ Our largest amount of funding is derived from the wonderfully orchestrated, highly successful Annual Book Sale, which this year netted an over-the-top \$14,000. These funds are the primary source for our three scholarship programs.
- ✓ Scholarships also receive designated financial support, both individual and organizational (thank you!!), such as this year's donations from The Cottage (Severna Park) and generous AAUW Branch Members
- ✓ Special Projects solicit and benefit from organizational donors. STEM Girls Count! remains especially grateful to Outreach Process

- to Anne Arundel Public Schools and Anne Arundel Community College for in-kind contributions. These funds are kept separately for support of the STEM initiative.
- The Branch Holiday Project, in which the Branch "adopts" an organization to support fulfill months: previously identified needs, such as clothing, etc., also acts as a self-funded project. Contributions collected from generous participants at the time of the December Holiday Luncheon and spent by our designated, energetic, and canny shoppers and giftdeliverers are warmly welcomed by a charitable organization, identified annually.

ANNE ARUNDEL AAUW BRANCH HISTORY By Terry Sayler

Fifty years ago, on July 6, 1966, the Severna Park Branch of AAUW was granted recognition by the national association. The road to the charter began on March 28, 1966 when more than 55 women met with the AAUW State President and Vice-President at the Severna Park Methodist Church to learn about forming the Branch. When the charter was granted there were 28 members, including Joyce Letaw and Eva Gustafson, still members today. By the end of the year the branch membership had grown to 88. The first branch president was Mrs. Paul J. (Sheila) Kiefer, Jr. Remember, those were the days when married women were known by their husband's name. Sheila would be our president once again from 1990-1992. (This article is in honor of our Branch's 50th anniversary this year!)

AAUW Educational Opportunities Funds provides funding for graduate women to further their studies, to work to improve their schools and communities, and to further opportunities for women and girls.

Anne Arundel Community College Transfer Scholarship awards for one year to female students who have attended Anne Arundel Community College and who are transferring to or continuing at an accredited four-year institution of higher learning.

Women to Women Grants for area women provide funding for Anne Arundel County women to improve their access to careers by empowering them with education. Awards are given to women returning to complete their degrees as well as those starting and continuing their education toward Associate, Bachelor and Master Degrees.
