PUBLIC POLICY By Roxann King and Vera Torrence

At 7 p.m. on January 9th and 11th, Vera Torrence will lead one-hour sessions about using the Maryland Legislature's website to track progress on bills and to research past legislative bills. The location has not yet been determined.

Vera Torrence and Roxann King attended the Maryland Legislative Agenda for Women's fall conference on Saturday, November 18th. Nineteen separate bills were presented for possible MLAW support during the next 90-day Maryland legislative session, which begins on January 10th and ends on April 9th. Our Branch is a member of MLAW, and as such, we will vote in December to decide which six or seven of the nineteen proposed bills MLAW will support in the 2018 legislative session. All the bills promote issues important to Maryland women and families (e.g. education, pay, leave, domestic violence, trafficking etc.). A description of each bill is available the MLAW website: on https://mdlegagendaforwomen.org/. Once decided, MLAW holds a reception in Annapolis in January to formally introduce support for the bills, which are presented by the lead sponsoring legislator. If you wish to attend this event, we need to know in advance, so we can ensure that you get the information you need to register early. It is free, but registration is limited.

WHAT A SUCCESSFUL BOOK SALE! By Stacey Hilder and Linda King

This year's used book sale was an overwhelming success every step of the way.

First was the beautiful weather the day of Severna Park's 4th of July Parade where we handed out 2500 book marks – 1000 more than any year in the past.

Then came the scheduled collections. As anyone who worked those days can tell you – we were inundated with books. By the end of our collections, the storage garages were overflowing and we had made a number of trips to sell un-needed books directly to Wonderbooks. Besides the books gathered during collections, various members were going to church flea markets, estate sales and private homes and boxing up books that owners were willing to donate.

Sale time!!! We moved thousands of boxes into the sale site on Friday, Oct 26th and the work began. By opening night, the members had managed to put out all but a few boxes of books What an amazing feat that was! By the end of the four days of the book sale, we had brought in \$14,255.

On the last day, we boxed up everything that remained. The books were transported to Wonderbooks in two rented trucks – we delivered 946 half boxes (which is 473 whole boxes) plus the 26 boxes of special books.

All in all, we took in between \$19,000 and \$20,000! After we deduct all of our expenses, we will have between 16 and 17 thousand dollars for our scholarship fund.

There were so many people involved in all of this work that it is hard to name them all. Most were members but a lot of them were just there to lend a hand. *Thank you so much*!

Appeal to our Philanthropists...


