AAUW USED BOOK SALE

What A Successful Book Sale!

As of Sunday afternoon, we had sold \$16,922 worth of books at the book sale itself. Prior to the sale, we had transported and sold 616 boxes of books collected after estate sales and from private homes to the wholesaler, WonderBook, for a total of \$2,480; AND on the Monday after the sale, we took another 621 boxes of books to that same wholesaler. That check will come to us in the next few weeks.

How did all this happen? It started when our members gave out 2500 book marks to the by-standers of the Severna Park 4th of July parade. Then in August, Sept, and October, members sat at collection sites from 10 am to 1 pm to accept book donations from the community. The YMCA in Arnold, the Bank of America on Benfield Blvd and St Philips Church in Annapolis donated space in their parking lots for us to sit and meet the community. Books were then taken to donated spaces where they could be sorted, repacked, and stacked until time for the sale. Jeanne Hawn let us use half of her garage (and then worked on the books after they were brought to her garage) and EZStorage in Arnold donated two storage units to us. Members worked at both locations for several days after the collection Saturdays to get the books ready to store.

On Friday, November 2nd, we moved into a storefront donated to us by the Fedder Corporation. This was the same site we used last year which meant we already had a following. Rented tables were delivered at 9 am and set up by our members. Signs were put up on the wall and the movers moved in the 2000 to 2500 boxes of books we had in the storage units. Dave Hilder volunteered to move the 800 to 1000 boxes of books in Jeanne's garage to the sale site during Friday and Saturday. He was helped by Dennis Hawn, Kirk Ferguson, Roxann King and Michele Hauf and her son.

Then it was time to set up the sale. At least 50 members, as well as friends and family members, came along to help, and worked from Friday until Wednesday afternoon setting up the sale. The last box of books was opened and emptied at 4:00 pm on Wednesday, just in time to get

them out for Members', Family and Friends' night. We started with 3000 to 3500 boxes of books. At the end of the sale, on Sunday afternoon, we packed up 621 boxes of leftover books to sell to WonderBook. The rest of the books were sold to customers or made available to community organizations that expressed a need. We allowed staff from a summer reading camp in South County to buy books at a discount and invited BIG (Books for International Goodwill) to come in, at the end of the sale, and take books they could use for their program. Since they are just getting started again, they were grateful for the offer and showed up with several trucks to haul books away.

As of this newsletter, the Anne Arundel Branch of the AAUW has earned \$19,402 by collecting and selling books and has supported two worthwhile community organizations. **What made this sale such a success? YOU DID!!!!** You showed up; you worked hard as you got to know each other; you bought books and you sold books; and you pitched in whenever and wherever you were needed. Most of all, you made it possible for us to, once again, provide scholarships to women who need help in order to continue their education. And that is the true gauge of our success. Thank you!

PUBLIC POLICY

Fifteen initiatives were presented at the MLAW (Maryland Legislative Agenda for Women) Fall Conference held on November 17th at Notre Dame University of Maryland in Baltimore. Of the fifteen, 6-8 will be selected by MLAW members to support during the upcoming 2019 Maryland General Assembly, which begins on January 9th. Shortly, MLAW members (including our branch) will rank the initiatives on importance and this will help determine the supported bills. Branch public policy committee members will participate in ranking the initiatives in December. If you join MLAW's list: (mdlegagenda4women@yahoo.com) you will receive notifications when actions are needed to support upcoming legislation on MLAW bills in the

General Assembly. You can also become an individual member: <https://mdlegagendaforwomen.org/join-mlaw/>.

AAUW Maryland is sponsoring two bills in the Maryland General Assembly. One, which would extend child support to 21 for dependents pursuing training or higher education, is the second proposal found at MLAW. The other is the Patient's Bill of Rights, which would require hospitals to adopt a uniform Maryland set of rights, train all staff in awareness of these rights, and communicate patient rights to patients in ways that can be easily understood. If you enroll in the national AAUW 2-Minute Activist, you will receive notice when action is needed on these two bills as well as on national issues. The most recent issue to be addressed by the national AAUW is the sweeping changes announced by the Department of Education to Title IX's regulations. The proposed rule would weaken Title IX's protections by narrowing the definition of sexual harassment to allow schools to exclude much of the abuse students experience, limiting when schools will respond, and putting in place processes that make it harder for students to come forward when they experience sexual harassment or assault. Over the next 60 days, we have an opportunity to weigh in with the Department of Education on the proposed changes.
