Hello to all and Happy 2019 - this is our year to move ahead and shine! Our branch is 90 members strong, the largest branch in the state. Now is the time for involvement by all. Your participation is wanted and needed.

As you will read in the letter from our state co- president, this year preparation will begin for celebrating the 100<sup>th</sup> anniversary of the 19<sup>th</sup> Amendment—we have the vote; we will make our every ballot count. Close to 25% of the current Congress members are women; and membership by women in the MD legislature has increased this year. Our own branch member, Heather Bagnall, is serving in the House of Delegates.

Our current docket is filled with many opportunities to participate in branch activities:

- The Program Committee has lined up engaging activities for the coming months, including a tour of MD state house, speakers, and C & Cs (conversation and cocktails).

# AAUW BOOK SALE By Stacey Hilder and Linda King

#### THE BOOK SALE CONTINUES

Just because the official fall book sale is over does not mean we have to stop raising money for our scholarship funds. The wholesaler we found in Frederick called Wonder Book takes books, DVDs, LPs, and CDs any time of year and pays us for them. Last year, we started the sale with over \$2000 in our book sale fund because of Wonder Book. This year, we can do the same and possibly even better with your help!

Where do the books come from now? The books we take to Wonder Book come from estate sales, homes of people downsizing, and neighbors and friends who know we will take them. So spread the word and keep your ears and eyes open.

How can you help us access books? Let Stacey (410-647-7041 or <a href="stacey861@verizon.net">stacey861@verizon.net</a>) or Linda (703-599-9646 or <a href="linda.king2939@icloud.com">linda.king2939@icloud.com</a>) know if you hear of an estate sale in your area or have a friend or relative who is willing to donate books. We can pick up packed boxes, or we can pack the books ourselves and move the boxes to storage. If the homeowner wants us to pack the books, it is helpful if you or the owner sends us pictures of the bookshelves or stacks, so we have a rough idea of how many members and how many boxes we need. With a name, phone number and email we can work with the owner to figure out when we should be there.

Neighborhood Collection Plan: If you live near someone who is donating books, we will call you and ask for your help. Not everyone can carry heavy boxes of books, but we also need help taking them off shelves and putting them in boxes, or packing up the DVDs and CDs. Sometimes we only have a few days' notice, so if you are available for an hour or 2, it is really important that you come.

One of the reasons we are able to continue raising scholarship money is that Michele Hauf allows us to store the boxes in her garage until we have enough for Wonder Book. The other reason is that Stacey and Roxann are willing to make the trip to Frederick as needed and have access to a pick-up truck or an SUV and trailer that can

handle the weight of the books. If you have such a vehicle and would like to help, it takes only about 3 hours to make the trip to and from Frederick where the Wonder Book employees unload the books.

If you have any questions, comments, ideas or suggestions, please let us know. Our scholarship funds are important to us, to the community, and to the women who receive the help they need. The more books we collect the more we can give!

### 100<sup>th</sup> ANNIVERSARY of 19<sup>th</sup> AMENDMENT By Susan Wierman Co-President, AAUW Maryland

The Maryland Governor's Commission on the Commemoration of the 100th Anniversary of the Passage of the 19th Amendment to the US Constitution has prepared educational resources for teachers and is sponsoring a contest for high school students (see attached flyer).

The Documents for the Classroom presents a very interesting survey of the history of women's suffrage in Maryland, beginning with a 1648 denial of Margaret Brent's request to vote, noting that women in some localities could vote on some questions, and explaining that while Republican legislators were generally in favor of the 19th Amendment, Democrats and urban legislators were generally opposed, and although enough states approved it and it was effective nationally in 1920, a Maryland attorney joined others in (unsuccessfully) petitioning the Supreme Court to overturn the Amendment. ## PUBLIC POLICY By Roxann King

AAUW Maryland is the initiator for two bills in the 2017 Maryland General Assembly. **The Patients' Bill of Rights** establishes a uniform bill of rights for all Maryland hospitals and requires related training of all staff and sharing with all patients. AAUW Maryland is also the initiator of the starred Maryland Legislative Agenda for Women (MLAW) supported bill below.

Below are the 2019 bills being supported by MLAW:

Family and Medical Leave Insurance Program. This bill establishes a private sector family and medical leave insurance fund to provide partial wage replacement for employees who take unpaid leave to care for a new child or a family member with a serious health condition, their own serious medical condition, or a family member's military deployment.

\*Family Law-Child Support for Post-Secondary Education-Jurisdiction of Court. The bill would allow the court to retain jurisdiction for child support until age 21 for those enrolled in post-secondary college education or a vocational training program.

Labor and Employment – Salary Information Disclosures. This bill prohibits employers from seeking and relying on job applicants' salary history and requires employers to provide the salary range for a position upon a job applicant's request.

**HIV Prevention for Rape Victims.** This bill provides rape survivors with n-PEP, emergency medication to prevent HIV.

**Prescription Drug Affordability Bill.** This bill creates a Prescription Drug Affordability Board in Maryland to evaluate high cost drugs and set fair rates for Marylanders to pay.

The Protect Maryland Health Care Act of 2019. This bill would create a Health Insurance Down Payment Plan which would give Marylanders at tax time without health coverage the option to either pay a fee or instead purchase health coverage, bringing more Marylanders into the individual market and stabilizing premiums to help with affordability.

**Protective Orders – Relief Eligibility – Rape and Sexual Offense.** This bill amends the definition of persons eligible for relief in a protective order to include a victim

of rape or sexual offense or attempted rape or sexual offense in any degree.

State Government Discrimination in Employment – Pregnancy and Childbirth. This bill expands existing pregnancy discrimination laws to include not just women with pregnancy-related disabilities, but also women with healthy pregnancies who also need reasonable accommodations.

**Expansion of Maryland's Vacatur Law for Survivors of Human Trafficking.** This bill allows criminalized survivors of human trafficking to remove crimes *other than* prostitution from their criminal records.

The Maryland General Assembly meets until April 9<sup>th</sup>. If you would like to help support these bills in a timely fashion, make sure you are on the MLAW email list and that you are an AAUW Two-Minute Activist.
